IRSPA EXECUTIVE BOARD MEETING AARP OFFICE DES MOINES, IOWA • April 3, 2019

The IRSPA Executive Board Meeting was called to order at 10 a.m. by President Chris Campidilli. Connie Eastman, AARP, welcomed us to Des Moines and started our meeting.

President Elect, George Holland, led the Pledge of Allegiance to the Flag. President Campidilli appointed Phil Tetzloff to serve as Parliamentarian. She also introduced Toni Hood, new Newsletter Editor, and Jane Beatty, new District 5 Coordinator.

The meeting agenda was reviewed and accepted as printed. Secretary Mary Jo O'Connell completed the Roll Call, and the names of attendees and guests in attendance are listed at the end of the minutes. Minutes of the Executive Board Meeting held October 3, 2018 were presented and available. Approved as printed. Toni Hood suggested that Minutes and important IRSPA documents be put into a digital format. The Historian will be going through the files this summer and determining what needs to be copied.

Bob Swanson, IRSPA Treasurer, presented the Treasurer's Report covering the period October 1, 2018 to April 1, 2019. Balance on hand as of 10/01/18 was \$42,015.97 and Balance on Hand as of 4/1/19 = \$38,422.75. Investments are as follows:

Money Market Account – Security National Bank, Sioux City = \$24,635.98

Certificate of Deposit – Security National Bank, Sioux City = \$51,676.07 @ .65% interest – matures 9/28/20

Goldman Sach Bank CD – Cetera Investments = \$50,000 @ 5% interest – matures 5/29/20

American Express CD – Cetera Investments = \$50,000 @ 2.05% interest – matures 12/23/19

Total membership at this time is 5,547. That includes 617 life members and 111 new members. The Treasurer's Report was filed for audit. Bob Swanson discussed the idea that the bulk rate we use has a statement to notify IRSPA if any Newsletter is not delivered. This is costing us money as the last Newsletter had 104 returns at \$.61 each. Only 19 of these resulted in a change of address. Toni Hood moved that Bob Swanson change the bulk mailing to delete "change of service requested". Seconded by Marge Swanson. Motion passed.

The President Elect:

George Holland, reported that Linda Miller, Mary Jo O'Connell and George have been working on Job Descriptions for members of the Executive Board. He had copies for everyone, and asked them to review their job description and send him any changes or additions. The final copy will be added to the new website. He also attended three Unit Meetings with President Campidilli – Henry County, West Union, and Davenport.

Past President Report: No report this meeting.

AARP:

Brad Anderson reported that the CARE Act passed this Legislature. This empowers care givers. Facilities need to give care givers information when the individuals they are responsible for leave their care. At this time, prescription drug costs will probably be AARP's next focus. They will be going around the state to determine what Iowan's need. Please watch for the Forums for the upcoming elections.

Committee Reports

Insurance/Benefits: Richard Rowland reported that membership remains AMBA's number one goal. Membership in IRSPA is important to help AMBA grow. They have helped change and update our website. They are waiting for information to setup online registration and payments. George Holland and Bob Swanson will continue to work with them on the website and social media posts (Facebook). They would like to start lunch and learn seminars for current teachers so that they are aware of IRSPA and AMBA.

Constitution and Revision:

George Holland distributed proposed changes to the Bylaws.

- 1) The committee moves that the following policy be approved by the Executive Board:
 - *Each local unit will recommend local unit members to serve on IRSPA committees at the District Meeting. (This will be a new item to the District Meeting Agenda.)
 - *IRSPA Committee members will be determined at each spring District Meeting by attending units through nominations and vote.
 - *Terms will be for two years with reappointment for two more years.
 - *Each District will recommend members to serve for three years beginning in 2019-2020 to create an alternating membership for three committees.
 - *Each District will recommend members to serve for two years beginning in 2019-2020 to create an alternating membership for alternating committees.
 - *The upcoming President-Elect will recommend appointment of new committee members at the Executive Board meeting in October for announcement of appointments at the Annual Meeting when the President-Elect becomes President. Motion Passed
- 2) The Committee moves to eliminate the requirement for officer membership in NRTA. Motion Passed
- 3) The Committee moves to edit IRSP Association to IRSPA. Motion Passed
- 4) The Committee moves to add AARP and AMBA as additional leaders, programs, and goals to add to this (5.) duty of President. Motion Passed
- 5) The Committee moves to add Historian to the Office of the Secretary. Motion Passed
- 6) The Committee moves to change the name of the Insurance Committee to Benefits Committee. Motion Passed
- 7) The Committee moves to change the name of Public Relations (Publicity) Committee to Public Relations Committee. Motion Passed
- 8) The Committee moves to place the Committee names in alphabetical order as names change and committees are added or deleted. Motion Passed
- 9) The Committee moves to add the AMBA Representative to IRSPA to the list of Executive Board Members. Motion Passed
Bylaw changes will be posted in the September Newsletter for consideration at the October Annual Meeting.

Historian: No report this meeting.

Health Advocacy:

Marge Swanson reported that "HIPAA, DPOA, POA, and funeral/legal issues" was the topic chosen for all of the District Meetings in

May, 2019. She is still working on arranging speakers at all six May meetings.

Legislative/AARP:

Phil Tetzloff reported that he has been in contact with John Caciatore, and at this time there are no changes to subcommittee bills. Remember that Legislators have publicly announced that there are no plans to introduce any bills that would impact IPERS.

Membership:

Gerald and Shirley Barth presented information that will be given to each local membership Chairman and President. This included information about getting new members and what IRSPA does. They also encouraged everyone to attend their District Meeting.

Newsletter:

Toni Hood reported that her first issue of the Newsletter went very smoothly. Please remember that any article can be submitted well in advance of the deadline. Pictures are also welcome. The June Newsletter will be published later than usual to allow for coverage of the District Meetings.

Public Relations (Publicity):

George Holland reported that Pre-Retirement Seminars with IPERS have been held in Mason City, Cedar Falls, Burlington, and Creston. Spencer, Sioux City, and Waterloo will host this summer or fall. A new membership brochure has been created. The form will be accessible on the website. A new format for our State Directory has been created. A copy will be on the website and updated as needed.

George Holland moved to have the Secretary buy a new big hole-punch. Seconded by Linda Miller. Motion Passed.

The District 1 Spring Meeting of IRSPA was held on May 21st at Redeemer Lutheran Church in Sioux City hosted by Sioux City Retired Educators (SCRE). There were 88 in attendance.

The meeting was opened by a reminder of our founder, Dr. Ethel Percy Andrus, a principal, who saw the need to help teacher retirees after she found an elderly retired teacher living in a former chicken coop. She started the NRTA, National Retired Teachers Association, in 1947 and AARP in 1958. Iowa formed its first state organization in 1951 (IRSPA).

The officers of the units in District 1 met in a separate group and had a discussion of helpful ideas for the units. The rest of those attending heard Marcia Poole, the director of the Lewis and Clark Interpretive Center, give a wonderful power-point presentation about the center.

We learned a lot about what to be aware of in a talk about "Fraud Watch" by Dr. David Chobar.

After a break Dorrie Wilson, a privacy officer at Unity Point Health St. Lukes, gave us information on HIPAA and DPOA.

After lunch was served by the Redeemer Lutheran Mission Group Dr. LuAnn Haase from Morningside College, talked about "What's New in the Education Department."

Paul Strid, the district manager of AMBA (Association Member Benefits Advisors) reviewed the benefits available to members and told us of new benefits that have been added. Phil Tetzloff of Marshalltown told us about legislative issues. He represents us as IRSPA Legislative Chair, IPERS BAC member and AARP Executive Board Member.



Dr. David Chobar spoke to the members about the growing need to be aware of fraudulent scams.


Dorrie Wilson spoke about HIPAA, DPOA, and end of life planning. (Dorrie in print shirt)

In 2020, the Johnson County Unit will host the May 21 Meeting in the Iowa City area.


