## ESTHERVILLE AREA IRSPA Spring 2023 Meeting

The IRSPA District 1 meeting was hosted by the Estherville Area unit at Iowa Lakes Community College on May 16, 2023. After the registration and refreshments, the group broke into break-out sessions followed by information sharing from the sessions.

The theme was "Out of This World" and that motif was appropriate for the first speaker of the day.

Lili Jensen, a former teacher and librarian, spoke about the unique meteorite that landed in Estherville on May 10, 1879. This is the largest meteorite that has fallen in North America. Bob Jensen, Lili's husband is fascinated by this event and has been instrumental in preserving and disseminating information about this phenomenon now known as the Estherville. The center slice of the meteorite is displayed at the Estherville Public Library; the Meteorite Museum is at the intersection of Highways 4 & 9. A second slice of the meteorite and a sculpture by an Iowa artist is also displayed there. Portions of the 744 pound meteorite have been displayed all over the world.



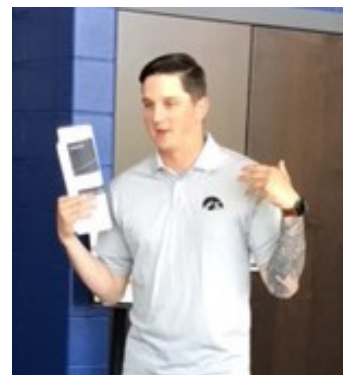
Joan Enockson, and ELC teacher at Estherville-Lincoln Central, spoke about her career, her varied life and teaching experiences, and what motivated her to become an author. Joan dreamed of being a children's author and by following her instincts and persevering she made this a reality. She started her own publishing company, Tall Girl Publishing, found an illustrator, and published *The Snail That Wanted to Hop*. Other books followed and Joan continued her theme of addressing the social and emotional needs of children, friendship, problem-solving skills, citizenship, and patriotism. Her newest series, *The Biker Grandma Series*, along with her other books are available at Amazon.com.



After lunch, AARP representative, Connie Eastman,

spoke about caregivers and their roles and responsibilities. Her topic, "Prepare to Care," informed the audience about the 48 million people of all ages and sexes who are family care givers. Adam Reiter, a student mental health provider at ELC, spoke about the social/emotional needs of students. Family and social dynamics have changed for a variety of reasons. These changes have impacted our youth in many ways. Reiter's program addresses many student skills such as self-management, wellness, self-awareness, relationships, safety, and social media issues.

### APRIL:

The Cherokee chapter of IRSPA met on Friday, April 14th, for the first time since November 2022. The group met at the Family Table in Cherokee, Iowa, where they enjoyed a program presented by Fran Briggs of Marcus, Iowa, entitled "My Mother's Apron/Tie One On."

showcased aprons she had collected and shared with other groups for nearly 30 years. She had some of her own grandmother's aprons that were over 100 years old. However, most of Fran's collection was made up of contemporary aprons of the 1950's and 1960's eras. She collected aprons that were made of linen, cotton and organza. Many styles were crocheted or had counted cross stitch on them and ran the gamut from work aprons to wedding aprons. Fran gave many of the IRSPA members the opportunity to model an apron or to "tie one on." Several members recounted memories of how the



different styles related to when they were growing up and/or of their own past apron experiences. Needless to say, the program was enjoyed by all in attendance.

#### **MAY:**

The Cherokee chapter of IRSPA met in the basement of the Presbyterian Church in Cherokee, Iowa, on Friday, May 12th. The members and invited guests enjoyed a brunch prepared by the May committee before the guest speaker, Senator Lynn Evans, presented his program. Senator Evans shared his insights on many of the new education bills/laws that were being acted upon in the state legislature this year. He very briefly touched on the new alignment law of the state which goes into effect on July 1st of this year, and he shared information about the changes instituted by other laws as they pertain to schools, students, books, libraries and educational funding. Hopefully, some changes will allow schools to use assigned funds in areas that need them rather than restricting them to only the categories where they were originally assigned. Also, some changes have been made to make it easier to hire teachers from other states, to allow current teachers (especially at the college level) to instruct level one and level two of a consecutive curriculum in the same room at the same time and to hire non-teaching librarians to help ease the current teacher shortage. Senator Evans was a wellhouse of information and presented a very informative program.

### **Iowa Retired School Personnel Association volunteer hours will be collected the end of August, 2023.**

The new value of each hour is \$31.80, 6.2% increase from 2022 which was \$24.69.

Almost all of our local chapters keep track of individual hours and once they are turned in, we send them to several state and national organizations. They compile information for reference by non profit organizations who need to apply for grants to continue their work.

#### **Here are tips for collecting volunteer hours:**

1. Appoint a person to be responsible for collecting, compiling and reporting the volunteer hours to us by August 31.
2. Mention the recording of volunteer hours at your meetings, informal get-togethers, and in your correspondence to members.
3. Try to have members separate their hours into two categories
  - a. Youth and Education
  - b. Community
4. Include the time spent traveling to or from the activity. Report hours in WHOLE numbers.
5. Tell members that they may count hours spend in UNPAID care-giving for family members.
6. Emphasize the importance of keeping volunteer hours.
7. Thank your members who keep their hours and turn them in.

## WEBSTER COUNTY IRSPA

Our program is on D/SOAC and Violent Crimes. Jamie Huse will represent D/SOAC and Marie Henry and Sheryl Kuchenreuther represent Violent Crimes.



D/SOAC stands for Domestic Sexual Abuse Outreach Center and opened in 1992. All services are free and confidential. They have a kitchen, living room, 9 bedrooms, 26 beds for men, women and children and cover 20 counties. From Jan. 1st to Dec. 31st, they served 332 clients.

Most times, the people just come with the clothes they are wearing. They are always in need of clothing and hygiene items. They receive counseling and they reach out to the community for resources. They help with court, dental and doctor.

For the 17 and younger, they do crafts, help them enroll in school, provide school supplies, they have birthday and Christmas parties, distribute Santa gifts that were donated.

They have a thrift store called The Key on Central where the proceeds go to D/SOAC. The clients can get free items here. They also have an on-line cake auction.

Violent Crimes covers 15 counties. Offices are in Fort Dodge and Waterloo. In 2021, they served 630 clients, and in 2022, they served 437 clients. They deal with things like vehicular homicide, hit and run, burglary, etc. They stay with the family, help make phone calls, etc.

Crime Victims Compensation includes \$7,500 towards funeral, work with funeral home, law enforcement, court, attorneys, trial, sentencing, support group.

They do receive federal funding. They also have a

golf tournament in August to raise funds.

Judge Brown announced that the District 2 meeting will be May 17th in Charles City.

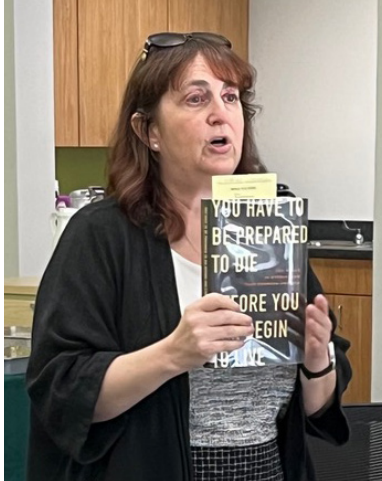




## MARSHALL COUNTY IRSPA

Our fine-free library is open 7 days a week. The newest project of the library is "MOBI," a new book-mobile that will be visible in the community this summer. The Humboldt Area IRSPA met April 10, 2023 at the Humboldt Senior Citizens Center; there were 16 members present. President Anita Fagen-Miller called the meeting to order and reviewed old business and then introduced Humboldt Middle School principal Cassie Smith who spoke about "What's Happening at the Middle School."

Cassie, a 15 year teaching veteran with many varied assignments, is in her first year as a principal. The HMS has 475 students in grades 5-8. We enjoyed hearing about all the changes education is undergoing. Middle school students are an interesting, yet challenging, age group. Group dynamics, cooperative skills, and social/emotional well-being are some of the areas Cassie touched on. Her audience laughed when she introduced all the acronyms that label the many initiatives that educators practice as they support student's academic and social growth; MTSS, PBIS, SEL, and FUEL are all programs that are new to our former school employees. The Humboldt district now employs therapists and behavior specialists that support the staff's effort to meet the needs of all students.

The May 9th meeting had 15 members present. Volunteer hours were turned in, a new by-laws committee was discussed, food pantry donations were accepted, and Candy Carlson provided some information about IPERS. Humboldt county has 540 retired recipients; their total IPERS payments are \$8,016,740. There are 6,262 new Iowa retirees; the average monthly benefit is \$2,041, and the average years of service is 22.2

There was no speaker, but the members enjoyed visiting. Anita Fagen-Miller initiated the conversation by beginning a round robin discussion; each member spoke about their educational backgrounds and experiences; it was a great opportunity to reminisce and share professional memories.

## JACKSON COUNTY IRSPA

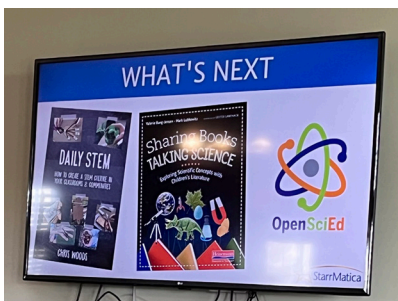

They need to be encouraged to wonder and ask questions and to understand that failure is expected.

In 2010 she was the winner of the IA Entrepreneur of the Year and featured on PBS. In 2013 she asked school districts what is needed and that is when she wrote 5 grants and developed 2 new products for STEM. She said research shows that we must get elementary age students interested in science. Students need to be asked "What do you wonder? How can we test this?" (when shown natural events). She suggests using picture books to present these questions but not to tell the answers.

One activity she suggested was to use the book *Twenty One Elephants* about building the Brooklyn Bridge and then do an activity where the students use pennies



to test bridges they build. Do not show examples. Let them create. Open Science Education is a website any school can use. We hoped that she will present to school districts because we liked her information so much!!

The business meeting followed and we found out who won our \$500 scholarship and decided to give \$100 to the two people who also applied and impressed us.

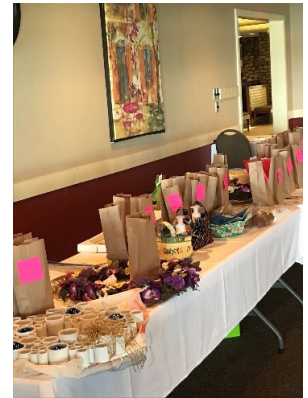

Kumar was a chef in his native country of Sri Lanka before arriving to the U.S. in 1986. He was fortunate to meet George and Jean Alton, both teachers in the Ft. Madison School district. The couple invited Kumar to share their home and gave him the opportunity to pursue higher education at SCC. With their passion for learning, Kumar was able to get the education he needed which enabled him to fulfill his American dream of becoming a chef and a leader of a healthcare organization.

To show his gratitude for the opportunities provided to him in Ft. Madison, he paid "it forward" by giving back to the community. In 2015, Kumar bought a building, 807 Ave G, remodeled it, and added a kitchen. His idea was to combine education with food. In Sri Lanka, teachers were highly respected, and he values education.

Kumar wanted a safe place for students to come after school. He named his program "Elliot" after James T Elliot, the successful healthcare businessman for whom he worked. Kumar contacted Mr. Elliot and asked if he could name his project after him. "Test" refers to education and "kitchen" refers to preparing meals for the children.

Kumar's innovative thinking started with 10 students but quickly grew to 30. The students arrived after school to the smell of cookies baking. This was "wind down" time from school. Students receive help with homework, in math, science, robotics, history, music and ACT prep. Many times, with busy family schedules, kids do not eat at home with their families. At the kitchen, kids learn to cook, prepare a meal, and eat to-



gether. Before eating, they offer a prayer to say what they are thankful for.

Due to the extraordinary success of the program Kumar needed grant money to expand. In January 2023, the Elliot Test Kitchen merged with the Ft. Madison YMCA, due to the success and growth of the program. This expansion enlarges activities for the children as attested to by with Karen Siefken from the YMCA who also presented with Kumar.
