It's News to Me ...

The following information covers a few salient points taken from "A Review of Articles from the National Center on Retirement Security." The review was compiled by Philip Tetzloff who is IRSPA's legislative chair, liaison to Iowa's AARP Executive Council, and a member of IPERS Benefits Advisory Committee.

- **Long Term Care Coverage through Medicaid:** 69% of seniors will require some type of long-term support and services for an average of length of three years. Half of Medicare beneficiaries in 2019 had savings below \$73,800, half of Black beneficiaries had savings below \$14,500, and half of Latino beneficiaries had savings below \$9,650. The national median cost for a year of nursing home care in a private room is \$102,204.
- **Women's Retirement Preparedness:** Older women receive approximately 80% of the retirement income that older men receive. Women are much more likely to work part-time, and women are more likely to take time out of the labor force to provide caregiving to their children and grandchildren, their elderly par-

ents, or an ailing spouse. More women are negatively affected by divorce and widowhood than are men. Approximately 76% of teachers are women.

- **The Growing Burden of Retirement:** Social Security now replaces less income than it did in the past. Housing, healthcare, and long-term care costs have increased and present greater obstacles. Adequate retirement security depends on Social Security income, pension plans, and personal savings. Less than half of all U.S. have access to a retirement plan through their employer. Lower interest rates impacts the income retirees receive from their savings. In 2019, only 37% of working adults thought their retirement savings plans were on track. Only 22% had money in defined pension plans. Emergency expenses of \$400 could not be covered by 36% of adults.

- **Fortifying Main Street:** In many small towns and rural communities, the largest employers are school districts, county and local governments, and state-federal agencies. Many of these employees remain in their communities after they begin collecting their retirement payments. In Iowa's 99 counties, pension benefit dollars contribute to the Gross Domestic Product. The smaller the county the greater the impact of pension dollars. Pension dollars have a "ripple effect;" one person's spending becomes another person's income. In Iowa, pension payments of \$3.55 billion supported 20,172 jobs. The impact for federal tax was \$270.7 million and \$280.3 million for state tax.

- **In 2019, only 37% of working adults thought their retirement savings plans were on track.** Only 22% had money in defined pension plans. Emergency expenses of \$400 could not be covered by 36% of adults. According to IPERS CEO, Gregory Samorajski, "IPERS' Trust Fund is strong and secure, and IPERS has the liquid assets necessary to pay monthly benefits for years to come."

While the IPERS Trust Fund's long-term outlook is positive, many Iowans are not financially secure due to many of the above cited facts. IRSPA members should be justifiably grateful for the security their pension payments provide. Because of the economic Pandemic damage, many of our citizens are experiencing financial, housing, and food related stressors. Please be mindful that our mission is "to serve, and not to be served."

LIMITING THE OUT-OF-POCKET COST OF INSULIN

Our Lobbyist at Work

HF 263 setting a cap on out-of-pocket insulin cost at \$100 for a 30 day supply, passed the House on **February 8, 2021**, with a vote of 89 - 2. Some of the text is below... IRSPA is monitoring the bill.

a policy, contract, or plan providing for third-party payment or prepayment of health or medical expenses that provides coverage for prescription drugs shall cap the total amount of cost-sharing that a covered person is required to pay per prescription filled to an amount not to exceed one hundred dollars for up to a thirty-one-day supply of at least one type of each of the following:


- a. *Rapid-acting prescription insulin drugs.*
- b. *Short-acting prescription insulin drugs.*
- c. *Intermediate-acting prescription insulin drugs.*
- d. *Long-acting prescription insulin drugs.*


ASK AMBA

Dear AMBA,

I'm a little confused about Open Enrollment. With everything that is going on in the world in 2020, life is confusing enough. COVID, the election, and all this advertising about open enrollment. How does this affect me and my Medicare coverage? Am I missing something?
