Bill was the Centerville H.S band director for many years. Enfys McMurray then presented a program on Flight 11, a story that many people in Southeast, Iowa are unfamiliar with.

Flight 11 is a book written by Enfys that tells the story of Continental Flight 11, a Boeing 707, that left Chicago, Illinois at 8:35 PM to travel to Kansas City, Missouri on May 22, 1962. Tragically, at 9:17 PM the airliner exploded and crashed with debris and remains of 45 crew and passengers in Appanoose County and Putnam County, Missouri. Subsequent investigation found that a passenger as part of a suicide insurance scam had carried a bomb on board. This terrible event was one of the first terrorist events involving an air craft. A memorial to Flight 11 is in Unionville, Missouri. Enfys' talk was well received by the members. The story of Flight 11 truly shows the need for security at our nation's airports.

DALLAS COUNTY IRSPA

At the first meeting of the new year, members of Dallas County Area Retired School Personnel and their friends paid tribute to Florence Heck, the last founder of the local organization who passed away July 8 at the age of 94.

Florence's teaching story started at age 17 in southern Missouri just 9 miles from the Arkansas line. She had taken an exam as a senior in high school that allowed her to teach for one year with the requirement that she take 10 hours of education each summer at SW Missouri State to keep that certificate. She next taught two years in a Catholic school before her father mortgaged his cattle so she could go back to SWMS to secure her two year certificate.

Although she had perfect credentials, no district would hire her because she was Catholic. Finally she was hired to teach in Couch, Missouri. On the passing of her mother, she moved to Des Moines where she taught school in the Army barracks on Army Post Road, met her husband Mel Heck, and took time off to raise their 6 children while also finishing her four year degree.

Upon completion of her degree, she was hired in Perry where she taught for 22 years before retiring in 1991. She started in first grade and went to kindergarten for the last 8 years. During that time she taught in almost every building in the Perry system finishing on the stage in the junior high. As she put it, "I spent my last years on center stage!"

Upon retirement, Florence was one of 38 retirees contacted by Grace Freestone to assist in the formation of a Retired Teachers unit in Perry. At a May 7, 1992, meeting with Ed and Hazel Chuck, co-presidents of the state organization, it was decided to pursue this idea. Former superintendent, Dr. Blaine Lytle, was present and suggested that ALL school employees should belong to this organization. He also suggested that Florence would make a good president and she, as well as Lois Seeley, Grace Freestone and Don Matthews, should be officers. No one was given a chance to say NO! In October, 1992, the state charter was received and the Dallas County Area Retired School Personnel Association was official.

Florence was a perfect example of the official motto "To serve, not to be served" as she guided our organization through all these years.

Dear AMBA,

There is so much uncertainty in the marketplace today. Interest rates are on the rise, to stave off inflation. There is talk of a possible recession by year's end. My friends tell me they cannot bear to even look at their 401K, 403B or IRA because they are losing money. Any investments tied to the stock market are so volatile right now. I feel like I am losing money with it being in the bank, since they are paying next to nothing in interest rates and inflation is around 5%. I've been reading about something called a Fixed Index Annuity, as a safe-haven for my investments. I am getting up there in years and know that if we go into a bear market, I may not have the luxury to wait for an 8 to 10-year correction, like what happened back in 2008. Any thoughts?

Dear Andy,

You are not alone. Not only are banks paying little interest, but they are also not the safest place to park your money. Four banks have gone under since March of 2023 and it is projected there may be more. Executive Committee Meeting

Members of the executive committee met August 1st at PolicyWorks in Des Moines. Those attending were: President Elect Jeanne Handeland, Vice President Beth Hieronymus, Secretary Mary Jo O'Connell, Treasurer Bob Swanson, Legislative Chair Phil Tetzloff, District 6 Coordinator Linda Miller, and District Coordinator 4 Venita Escher. President Jean Hoffman and Newsletter Editor Toni Hood attended via Zoom.



John Cacciatore, one of our lobbyists, shared noteworthy legislation from the 2023 session.

Lobbyist John Cacciatore shared with the group noteworthy bills of interest to IRSPA members during the 2023 legislative session. The first was the additional homestead tax exemption for those age 65 as of January 1, 2023. The second was the voucher bill. Several issues were raised regarding that bill including the fact that taxpayer money is now being used to finance education in private schools even though there may not be a private school nearby, and private schools can pick and choose who is allowed to attend their school.

John also shared that there is a new state committee that will review Iowa's 256 boards and commissions to reduce the number of committees and improve efficiencies. The committee had its first meeting in late June. The next meeting is August 29th when they will reveal their recommendations, and a public hearing will follow on September 6th. PolicyWorks will monitor the subcommittee's recommendation in case there are significant changes that may negatively affect IRSPA members. Phil Tetzloff attended an IPERS BAC meeting on July 31st and indicated that no concerns were raised at that meeting regarding the reduction of committees.

Treasurer Bob Swanson presented the proposed budget for October 2023 through September 2024. The budget is a 4.7% decrease from the previous year. It will be presented at the annual meeting.

Toni Hood addressed concerns about the newsletter. It must be printed in 4-page increments. The June newsletter was quite large with the coverage of district meetings. The executive committee would like to encourage members to access the colored newsletter via the IRSPA webpage rather than receiving a mailed

copy; this would substantially reduce costs.

The legislative representative position was discussed and questions prepared for the interviews. Interviews will be held on August 28th at PolicyWorks.

The executive committee recommended including a scholarship standing committee in the constitution and by-laws; this addition will be presented at the annual October meeting.

A reminder: send your registration and check for the annual meeting by September 15th to Peg Lewis, 803 Goldenshores Ave., Creston, IA 50801. The only fee is for the meals--\$30 for Wednesday night's banquet and \$23 for lunch on Thursday.

As of July, 2023 IRSPA had 5,286 members. From October, 2021, until September, 2022, IRSPA lost 483 members. We gained 308 members which resulted in a deficit of 175 people who are "proud to serve, and not be served." There is strength in numbers. With that in mind, I've compiled some ideas that some units are already using to recruit new members.

- ❖ Remember IRSPA membership is not only for teachers. Any retired school employee is eligible to join.

- ❖ DID YOU KNOW that "Friends of Education" are able to join IRSPA? Anybody who wants to support our efforts can purchase a membership and attend meetings.

- ❖ Be visible in your local schools. Give school supplies to elementary schools. Schools appreciate mittens, hats, and socks as well as classroom supplies.

- ❖ Organize a book drive and donate age appropriate books to local classrooms.

- ❖ Consider giving a membership to a friend as a gift. The recipient will be able to take advantage of many IRSPA benefits while enjoying the available social opportunities.

- ❖ Depending on your unit's budget, consider giving complimentary memberships to as many retired teachers as you can afford, and invite them to attend a meeting. One unit draws the names of two new retirees each year, or you could just choose people who you think would be interested.

- ❖ Send congratulatory retirement cards to new retirees, invite them to a meeting, and encourage them to join IRSPA. Perhaps treat them to a meal or a snack.

- ❖ Consider hosting an informal coffee for new retirees.

- ❖ Challenge your members to recruit new members and give prizes to those who have helped grow your unit.

- ❖ Unit coordinators could challenge their units to enroll new members. A prize could be given to the unit(s) that were successful.

- ❖ Submit your unit's news to the local paper and include information about how to join IRSPA. Send your unit's volunteer hours report to your local paper with an explanation that emphasizes IRSPA's local and state contributions.

- ❖ **The articles and pictures you submit to our newsletter could also be sent to your local paper.**

- ❖ Send "thank you" goodie trays to teacher lounges to celebrate the end of a successful school year. Include information about IRSPA.
