

Zoom • April 7, 2021

The meeting was called to order at 9:00 a.m.

President George Holland introduced our new representative from AMBA, Larry Newman. Larry has worked with AMBA for 13 years and has enjoyed working with the Associations.

Secretary Mary Jo O'Connell completed the roll call. The Minutes of September 2, 2020, were approved as printed.

Officer Reports

President – George Holland. Presented a report listing all his activities since the last meeting.

Vice President – Jean Hoffman. She has been meeting with the Scholarship Committee establishing guidelines and application for an ISEA Scholarship (PH Balanced Scholarship). She is continuing to learn about Zoom.

Secretary/Historian – Mary Jo O'Connell. No report because of COVID.

Executive Committee Reports

Treasurer - Bob Swanson. We have 5,558 members. Even during the time of COVID, the following Units met their membership goal:Black Hawk, Estherville, Muscatine, Sioux City, Van Buren, and Winneshiek. Bob transferred \$40,000 from checking into savings in the Money Market Account because canceled District and State Meetings in 2020. AMBA will look into the reason why some members received an increase in Delta Dental dues and others didn't. **The Treasures Report was filed for audit.**

AMBA – Richard Rowland, Paul Strid, and Larry Newman. Membership is their number one goal -247 new members in 2020. AMBA has less than 17% of members' email addresses. They will hire a company to do a search for members' emails. They will be starting Seminars. There has been a concern about Delta Dental. Some members have received a notice of a rate increase and others have not. They think that part of the problem is that Delta Dental deals with some members and AMBA deals with others. They will check it out and arrange a meeting with George. One of their goals is to hire new Representatives in Iowa. AMBA wants to partner with the Retirement Seminars. AMBA is starting a Fixed Indexed Annuity Program for members who are interested.

Health Care Advocacy – Marge Swanson. She said that "Covid 19" would be the topic for the District Meetings.

Legislation – Paul Tetzloff. The Investment Division of IPERS is looking to hire an internal staff. The only changes scheduled for IPERS is language. Our plan is in good shape. AARP has cancelled all activities until at least 2021.

Membership – **Barb Bielenberg**. She sent emails to all units with suggestions on getting out information to current members for renewal and new retirees from this year. **Nominating** – **Linda Miller**. They have a candidate for Vice President, Jeanne Handeland. She has been working to start either online voting (Survey Monkey) or a paper ballet for the next election.

Public Relations – George Holland. He has updated the website. He separated the Directory into five sections for easier use. He is looking into a new IRSPA banner for the State Meeting.

Supportive Services – Sandy & Jay Thede. A communication was sent to the Coordinators of the IRSPA Units reminding them to let their members know we are still keeping volunteer hours. These hours will be turned in at the end of August.

Unfinished Business

Elections - Linda Miller has been working to have elections either with Survey Monkey or a paper ballet.

70th Anniversary – We will be updated as plans are made. **PH Balance Scholarship** – **Jean Hoffman** presented the committee report establishing a scholarship for students who have lost a parent. The scholarship will be presented at the State Meeting.

They will give members a discount if they show a membership card. George Holland, Jean Hoffman, and Mary Jo O'Connell will meet to look into partnerships.

It was moved by Jean Hoffman to accept Hotel Pattee in Perry as an IRSPA Partner. Seconded by Jay Thede. Motion passed.

It was moved by Jean Hoffman to incorporate the Ameritas Flexmark Fixed Index Annuity as a new supplemental benefit provided to members of IRSPA, by our partner, AMBA. Seconded by Sandy Thede. Motion passed.

It was moved by Linda Miller to promote each unit's participation in attending the Annual State Meeting. One night's lodging for the President and one additional night's lodging for another member will be provided by IRSPA. Seconded by Sandy Thede. Motion passed.

It was moved by the Scholarship Committee that IR-SPA proceed with the initiation of a statewide scholarship called PH Balance Scholarship. Motion passed.

It was moved by the Scholarship Committee that initial start-up funding for the PH Balance Scholarship will come from the IRSPA treasury. Motion passed.

It's News to Me ...

By Toni Hood The following information was provided by Candy Carlson, the Humboldt Area IRSPA Unit's Legislative Chair:

• IPERS's CEO reported that in 2020 IPERS received 92,545 phone calls, counseled 7,593 members, and prepared 31,078 benefit estimates.

• The Public Health Emergency Proclamation makes it easier for retired IPERS members to return to work.

• Retirees who are younger than age 65 are no longer required to pay back a portion of their IPERS benefit if they earn more than \$30, 000 annually.

• Retirees who are younger than 70 are no longer subject to the mandate that they could not return to work for an IPERS-covered employer until they had received at least four monthly benefit payments.

•"My Account" is your IPERS retirement toolkit. "My Account" gives you access to your individual retirement benefits information. It can allow you to: view your benefit payment history, change your tax withholdings, change your direct deposit information, and view your income tax verification information.

• You can set up your "My Account" by calling 800-622-3849.

At the end of the 2020-21 school year, many of lowa's school employees will be retiring. IRSPA offers many personal benefits, contributes to the economic health of our state, and our members support many volunteer efforts. I thank our IRSPA units, as well as our individual members, who will be contacting newly retired school employees. As we increase our membership, we increase our mission "to serve, and not to be served."

IRSPA & Delta Dental Plans

On April 13, 2021, George Holland (IRSPA), Mary Jo O'Connell (IRSPA), Paul Strid



(AMBA), Richard Rowland (AMBA), and Ryan Motola (AMBA) met to discuss Delta Dental and IRSPA members. Some members were getting notification of rate changes and others were not. Simply, some members get their coverage through Delta Dental out of Johnston, Iowa, while other members get their coverage through our benefits provider: AMBA. Sometime around 2011, AMBA took care of benefits enrollments for IRSPA members. (Previously, an IRSPA board member enrolled members in Delta Dental.)

Rate Update

• The rate update occurred on March 1, 2021 for ALL IRSPA participants; those administered by AMBA AND those administered by Delta Dental of Iowa.

• Monthly Rates from 3/1/2021 Through 2/28/2022 for ALL IRSPA participants:

• Member Only \$39.50; Member+1 \$79.60; Family \$98.03

• The rates are guaranteed through 2/28/2022 but we could see a change on 3/1/2022. AMBA and IR-SPA leaders will meet in January 2022 ahead of this change to inform all IRSPA Participants.

Notifications

• AMBA sent rate notice notifications to participants that AMBA administers.

• For plan participants that Delta administers, they did not send notifications to those paying monthly. Annual payers will see the new amount on their annual invoice.

• This caused some confusion that members could be paying different rates for the same plan. AMBA confirmed with Delta Dental on 4/13/2021 this was not the case. The rate is the same for ALL IRSPA participants.

Plan Changes

• Dependents on the plan may stay through age 25 (was previously age 24).

• All waiting periods were waived effective 3/1/2021 and going forward.

We enjoyed a program on the Hardin County Farm Museum located in Eldora. It was presented by Richelle Ziesman Stowe whose father was instrumental in getting the project started. The 12 acre museum features equipment, agricultural practices and history of Hardin County farming from the 1800's to the 1950's. The museum's purpose is to preserve the memories of times past and to feature the great amount of work our ancestors did with the existing machinery.



The focal point is a 38x80 foot round-roofed barn built in the late 1930's as a dairy barn. A country school built in 1882 was added to the museum along with a church built in the 1930's and moved 15 miles to the museum site. A large chicken brooder house and a smaller red barn have also been added. There are over 90 large machines and over 400 smaller antiques on display in the largest barn. The museum hosts monthly pancake breakfasts, a tractorcade, suppers and barn dances. In the fall, there is a thresher and power show that demonstrates the machinery. The museum is a great place to visit or to volunteer.

We look forward to new ideas as we hear about other chapters' programs, projects, and fund raising ideas.

Criminals look for easy targets, SO environments, lighting, and security measures should be examined. Interestingly, he said that security alarms don't always offer complete protection due to the time it takes for law enforcement to arrive. He noted that 99 percent of all

home security alerts are false alarms. It is also important to find a way that can offer easy access to your home if there is a medical emergency; this would prevent damage to your home should a forced entry be necessary.

Cyber security is a real danger, but he advised the audience to be safe but to not let fear of technology limit their lives. Sanders finished his presentation by assuring us that the police department is the citizen's department, and he is very interested in becoming part of our community and strengthening community relationships. Children's Book Published by a Member of Webster County Unit By Cheri Maehl, President Webster County Unit



Julie Hoesel, a Webster County Unit member, recently wrote a children's book. The book was requested by CJ BioAmerica's Senior Operations Manager Luke Palmer. CJ BioAmerica has been part of the Webster County community since 2013. "Luke dreamed up this project.

It was Luke's vision was to promote literacy and to incorporate the values of CJ BioAmerica of Integrity, Passion, Creativity and Respect," Hoesel said.

CJ BioAmerica is part of the Livestock and Other Animal Food Manufacturing Industry with a large operation at the lowa Crossroads of Global Innovation industrial park west of Fort Dodge. Palmer came to Hoesel with his idea. He already knew she could write children's stories as he had "inside information." Hoesel is his mother-in-law and she has written books for his own children over the years!

Hoesel is a retired Language Arts instructor from lowa Central Community College. She retired in 2015, but Palmer didn't approach Hoesel about writing a book until 2018. "I chose the characters of Chessie the chicken and JoJo the pig for the book. Since CJ Bio uses amino acids from the local plant to go into feed for those animals, they seemed the perfect choice. The character's names were chosen for the company's name: "C"-Chessie and "J" for JoJo. Initially, there was to be only one story; but once I got started, I couldn't stop. I wrote three stories and the book became a chapter book. The book is called "Chessie and Jo-Jo Make Their Way," said Hoesel.

Palmer's plan was to give the book to every secondgrade student in Webster County. That plan came to fruition last fall. Each year, the second graders will receive their "Chessie and JoJo Make Their Way" book from CJ Bio. The books are not for sale, but several copies will be given to the Fort Dodge Public Library.

The book was illustrated by Jennifer Bemrich Dutcher, who was Hoesel's art instructor friend at ICCC. "I loved the way she drew the character's and illustrated the book, it was just what I had in mind," Hoesel explained.

In comments made to the Fort Dodge Messenger, Palmer said, "This is something that is really unique that we could do for the community. When I first started at CJ my first job was trying to help embed CJ into the community. Because I am from Fort Dodge and I've been here my whole life, that philosophy of working with the community instead of just working in the community really rang true for me."

Hoesel was asked if there would be another book down the line. She said she had no idea; but "I have a few ideas I am kicking around in my head, just in case I am asked."

Hoesel has been a member of the Webster County Unit of IRSPA since 2016. She is a member of the Book Committee, which collects, sorts, and levels books for distribution at Christmastime for area children in need.

"I've always loved children's books and reading to and with children. Helping children learn to love reading has been important to me all my adult life, and being on the book committee with like-minded people is enjoyable," Hoesel said.

It was a picture of a note from Pat Axne, one of our members. Pat explained that her mother, Agnes Mumper turned 100 years old in October 2020 and that Agnes had been a member of our group many years ago.

Agnes wanted to

donate \$100 to the Border Plains School at the Fort Museum in Fort Dodge because her first teaching job was at the Border Plains School!

Our unit has had the Border Plains School as one of our special projects for 43 years. The school stood proudly, serving the children of the surrounding area from 1857-1959. Then, in 1964, the school was moved from its original spot in rural Webster County to the grounds of the Fort Museum and Village. In 1978, our Webster County unit was invited to provide help in restoring and maintaining the one-room schoolhouse. Since that time, we have donated \$100 annually to the Fort Museum to help with the maintenance of the schoolhouse. We make an annual donation to honor the memory of our members who have passed away.

Agnes taught at the Border Plains School from 1940-1944. She was only 19 years old when she completed her two-year teacher training at Iowa State Teachers College (now UNI) and was hired to teach the 22 boys and 10 girls at Border Plains School. Her extra chores in those days was to build the fire in the heat stove and sweep the floor. The children would help bring in the well water each day. After the chores were done, she had to teach all 32 children, ages 7-14, who were squeezed into that one-room school!

"I had a 16-year old boy in my class when I started. He quit coming and I overheard him saying he didn't want that "kid" to be his teacher," Agnes said with a smile. "Most other teachers were women in their 40's or 50's; since I was only 19, he thought I was just a kid. There were others who thought I was too young to be a teacher, so I had to show them I could do the job."

When Agnes left the Border Plains School to teach at Lehigh, the children's parents gave her a beautiful quilt. "I could see the fabric from some of the little girl's dresses sewn into the quilt squares," she remembered. Agnes completed her Bachelors' Degree in Teaching during summers.

It was a delight to visit with Agnes. Those four decades of teaching elementary-aged children kept her mind sharp and her conversation lively and interesting.

Daughter Pat, also one of our unit members, had a 41year teaching career before retiring in 2017. She taught English and Spanish for 28 years in Lake City and Spanish for 13 years at Fort Dodge Senior High. Agnes' oldest granddaughter is also a teacher. The teaching tradition runs deeply in this family!

Page 12 Where to Work for Volunteer Hours

Many of our normal activities have been halted or changed this past year because of the Corona Virus. Hopefully, we are slowly coming back to "normal" life and are picking up where we left off last March, 2020. This is a reminder to all IRSPA members that we are still keeping track of volunteer hours no matter how few of hours they may be. The following are examples of what you may count.

Any time a member works for no pay or no reimbursement, they may keep track of that time. Hours are divided into: Youth and Education and Community. This means that when working with public or private schools, Boy or Girl Scouts, 4-H, caring for your grandchildren or others, this all counts. You may also count the time it takes you to drive to and from the babysitting/caring work. Youth programs, working with speech and drama students, being an aid during testing, assisting in music with youth, spelling bees, Kids Against Hunger Program, Dollars for Scholars work, working free with any organization that serves children or youth counts, and these hours are recorded under Youth and Education. You may work with Boys and Girls Homes, Child Development Centers, Children's Shelters, GED programs, testing sites, Scholarship Committees, etc.

All other volunteer work should fall under COMMU-NITY when dealing expressly with non-student age. Examples are: volunteering at Libraries, Museums, Churches, Church Committees, Community Centers, Senior Citizen Centers, Fundraisers, Parks, Recreational Areas, Hospitals, Community Kitchens, Food Banks, Hospice Facilities, Nature Centers, Chamber of Commerce, Health Centers, Local Historical Sites, Fairs, Theaters, Cemetery, Genealogical Society, Opera Houses, Meals on Wheels, Soup Kitchens, Church Mission Work, Legion Work, Grant Writing, Assisting the Elderly, the Humane Society, and Planting Flower Areas all count. You may volunteer at organizations such as the AARP, Elks, NRTA, NA ACP, Delta Kappa, Lions and others. Providing rides to appointments, helping at nursing homes, assisted living, family care giving, SHIP, Elder Affairs, tax and legal assistant work, rehab. centers, Recovery Therapy, visiting shut-ins, American Legion, VFW, service organizations and Auxiliary Units, etc.

It is important to keep your volunteer hours and report them to your local unit coordinators by the end of August of 2021, so that lowa can receive much needed grants that are based on volunteerism. Jay & Sandy's Phone Numbers is: 641-425-2394 (Cell)

My husband and I are in our late 60's,

early 70's and I am starting to worry

IRSPA will proudly launch a new scholarship during our Annual State Meeting & Conference in October.



The Parent in Heaven (PH) Balance Scholarship is intended for a high school senior who has lost a parent or legal guardian and forever feels that void. As teachers or people involved with schools, we understand the necessity of the support that comes from the home and the void that is created when a child loses a parent, both parents, or legal guardian due to death. There is a void that can never be fully filled.

The PH stands for a parent in heaven. Balance is the support that is given to the child in the form of a scholarship. We know that nothing can ever fill that void or bring the parent back, but we want the child and his/her family to know that no matter when or how you lost your parent, we recognize that void and would love to show you our support and wishes for a bright future.

Our initial \$1,000 scholarship will be presented at our Annual State Meeting & Conference at the Honey Creek Resort in October of 2021 to a student graduating in May 2022. Because the logistics of beginning something like this can be overwhelming, we are starting with one scholarship this year. The student will come from District 5, the location of the state meeting, which covers the following lowa counties: Polk, Jasper, Poweshiek, Warren, Marion, Mahaska, Lucas, Monroe, Wapello, Wayne, Appanoose, and Davis.

Qualifying students living or going to high school in those counties may apply for the first scholarship. The scholarship will move to a different district each year until voluntary funding will allow us to reach our goal of one per district per year. When we reach that goal, we will present the scholarships during the May district meetings in hopes that our recipient will be close enough to attend. Qualifying students may plan on going to a four-year college, a community college, or a technical school with plans to earn a degree or diploma for their desired field of study. The scholarship is payable to the school they attend after the completion of the first semester and continued enrollment for second semester.

Applications may be obtained by contacting an IRSPA Unit President; President-Elect of IRSPA, Jean Hoffman; or by talking to your school's guidance counselor (District 5 counties).


